MICHIGAN BORDER FROZEN ROAD APPLICATION/PERMIT

This permit grants the applicant permission to haul loads of raw forest products, lumber, or forestry biomass heavier than 80,000 lbs., on County Highway N in Florence County, ONLY when the Frozen Road Law is in effect. It is the responsibility of the permit holder to ensure the Frozen Road Law is in effect on the day of hauling.

The applicant must provide a copy of their Michigan registration. The vehicle configuration, length and weight must comply with Michigan law, not to exceed a GVW of 164,000 lbs. when hauling.

Individual permits will be granted at the discretion of the County Highway Commissioner and subject to review by the County Highway Committee.

Copies of each permit must be given to the Florence County Sheriff's Department **by the person receiving the permit.**

This action is being taken with the view that we are not curtailing businesses of a vital nature and that cooperation from the business will be necessary to make the permit system work.

The permit holder will be responsible for any damage he/she has caused to the highways while hauling under the conditions of the special permits.

This permit will authorize a trip originating and ending in Wisconsin without entering Michigan.

The Florence County Highway Commissioner reserves the right to revoke this permit at any given time, for any given reason.

Any permit holder who is found in violation of the conditions of the special permit will have his or her permit revoked and will not be granted a permit for a period of at least five (5) years.

This permit must be carried in the truck at all times.
