Booth Fee Rules

- All spaces will be assigned on a first come first (paid) serve basis. Be sure to indicate the number of spaces/tables requested.
- Include a self-addressed stamped envelope for written confirmation if desired. **No phone confirmations.**
- Payment in full is required to guarantee your space, and it is required before any space will be assigned.
- Payment will not be considered complete until your check clears the bank. There will be a \$30 service charge for any checks returned for insufficient funds.
- Checks may not be cashed immediately. It may take up to one month. Payments will not be refunded for any reason.

Set-Up Times

- We will arrive Saturday morning by 8am for set up.
- All vendors must arrive by 9am or their space may be re-assigned. If you are unable to make the show, call us so we can fill that spot. Chairs are provided.
- All booths must be ready for business by 10am.

Vendor/Facility Rules

- No chairs or displays are allowed in the aisles. Fire exits and aisles must be kept open at all times.
- No items may be used that could damage or destroy the floors or walls.
- Vendors will be instructed where to unload/load.
- All trash from your booth must be disposed of prior to your departure.
- Parking in the area is limited. For that reason, please move your vehicle away from the building after unloading and park behind the school.
- Tear down prior to 3pm is prohibited.
- We reserve the right to reject any items deemed inappropriate.
- All spaces are assigned. Relocation or switching will not be permitted.
- All vendors will be kept in the HS gymnasium. Vendor locations will be assigned on a first-come, first- paid basis. The HS hallway will be our overflow if needed.
- Food available to purchase-Staff will take food orders for your convenience.
- The High School is a non-smoking facility. No carry-ins of any alcoholic beverages will be allowed.
- No overnight parking allowed.
- If you fail to follow these guidelines, you will not be allowed back in the future.
